To: Shipping Lines, Shipping Agents, and Valued Customers

To ensure smooth and uninterrupted services during New Year and Tet Holiday 2026, SP-ITC International Container Terminal hereby advises our operational plan as follows:

1. Official holidays:

- **New Year 2026:** 04 days off (from Thursday, 01st January 2026 to Sunday, 04th January 2026).
- **Tet Holiday 2026:** 09 days off (from Saturday, 14th February 2026 to Sunday, 22th February 2026).

2. Operational plan:

During the official holidays defined in item No.1, SP-ITC Terminal will maintain operations including loading/discharging, laden containers dropping off loading/discharging and empty containers lifting on/off as usual. For other services, we will observe the working time guided in general stipulation by the Government on public holidays.

Upon special requests for services other than the above-mentioned operations during National Day, kindly send us a written notice before 24th Dec 2025 and 06th February 2026 for services to be carried out during New Year and Tet Holiday respectively. 3. Storage free time:

In order to support Shipping Lines, Shipping Agents, and Customers, in addition to the storage free time stipulated in the terminal contracts, SP-ITC Terminal will additionally waive storage charges (in container yards) during the holidays as follows:

a. Applicable categories:

Laden import containers, laden transit/transshipment containers, laden temporary import for re-export containers.



b. Free time:

- **New Year 2026:** 04 (four) days – from Thursday, 01st January 2026 to Sunday, 04th January 2026
- **Tet Holiday 2026:** 09 (nine) days – from Saturday, 14th February 2026 to Sunday, 22th February 2026.

Moreover, during the holiday period, on-duty departments at the Terminal will continue working as scheduled, and SP-ITC kindly recommends Customers arrange on-duty personnel to promptly coordinate and resolve any arising matters.
